- Jennifer noted that scheduling would be a nightmare to get this done.
- Stacy noted that state discussions continue and wanted to raise it for discussion with this transition committee.
- Tamara further pointed out that the two programs have very different focuses;
   i.e. developmental vs. educational.
   They are looking at different things.
- Jennifer noted that the criteria would need to be revamped in order for it to work.
- Ryan noted that it would be a scheduling nightmare for Assessment teams and school eval. teams.
- It was noted that it is really recommended for children who are 33 months or older should go to the school directly.
- Those that are 34 months and older are already being directed to the schools and then they have 50 days to complete an assessment.
- Betsy raised the fact that some families are just difficult to get a hold of and service coordinators have to chase them down. Sometimes families say they do not want school services only to say that they do right before the child's third birthday. This makes the school have to hustle in order to get them in for an evaluation.
- Betsy indicated that the current 30 month lists that the SPOE's send are very helpful. Helps to ensure that they are on top of possible children coming to the school system.
- Ryan shared that he has been extremely busy already this school year with 104 case conferences!!!
- Joan shared that she does appreciate when a First Steps eval has been completed on a late referral as it gives
